## ClearVue secures first Australian solar windows order with CFMEU for façade feature of new Wellness Centre in Melbourne

### HIGHLIGHTS

- ClearVue receives first commercial order in Australia to supply Generation 2 ClearVue<sup>PV</sup> solar windows for the CFMEU Training and Wellness Centre in Melbourne – the company's first order for a solar façade
- ClearVue's technology was selected and specified by award-winning Australian architect Hayball due to its exceptional sustainability benefits and high performance.

**10 January 2024:** Smart building materials company ClearVue Technologies Limited (ASX:CPV OTC:CVUEF) (*ClearVue* or the *Company*) has received its first commercial order in Australia from construction company Kapitol Group for a new commercial building project for the Construction, Forestry, Maritime, and Employees Union (*CFMEU*) in Melbourne.

The CFMEU will incorporate Generation 2 ClearVue<sup>PV</sup> solar windows into the façade of its new Training and Wellness Centre in Carlton - making it the first project in Australia to specify ClearVue's unique solar glazing technology from the outset. The ClearVue<sup>PV</sup> solar glazing is expected to be installed in or around April 2024.

Commenting on the project, Martin Deil, Global CEO of ClearVue, said:

*"This is a significant milestone for ClearVue as we have now commercially launched in Australia. We are thrilled this first order is with the CFMEU and that the building will be constructed by Kapitol, a group that's leading the industry in engaging sustainable suppliers on their projects."*

*"We are proud that award-winning architect Hayball recognized the value of our unique solar glass technology by incorporating it into the project design."*

*"Our solar glass windows generate the highest energy of any comparable solar glass on the market, with strong insulation and thermal performance which reduces heating and cooling loads and can be mass produced on a standard unmodified production line."*

*"We are excited that Hayball and the CFMEU recognised ClearVue's potential as the best available clear BIPV technology from the project's inception. To have our IGU system written into the specifications is a true showcase for the viability of integrating solar power directly into new builds and retrofits. We are grateful for the opportunity to bring our products to the attention of forward-thinking Australian architects, façade manufacturers and construction specialists."*

Kapitol Group's Project Manager on the CFMEU Training and Wellness Centre, Tom Stephens, explains the importance of engaging sustainable suppliers on Capitol's building projects:

*"One of our core company values is to 'do no harm', and engaging with suppliers like ClearVue means we can build more sustainable buildings that will minimise their environmental impact for decades to come."*

The decision by the CFMEU marks the organisation's commitment to explore new building technologies that will have significant impact in reducing carbon emissions from the built environment. It also demonstrates the union's support for ClearVue as an Australian solar building materials company.

Project architects Hayball ([www.hayball.com](http://www.hayball.com)) aim to receive a 5-Star GreenStar certification and a Gold WELL certification for the project with ClearVue's solution an integral part of the submission.

Whilst the revenue from this project will not be significant, the project is a significant step forward for the Company as its first commercial solar façade installation. The Company looks forward to updating the market on this project as it progresses.

Solar PV cells are incorporated around the edges of an Insulated Glass Unit (IGU) used in windows and the lamination interlayer between the glass in the IGU incorporates ClearVue's patented proprietary nano and micro particles, as well as its spectrally selective coating on the rear external surface of the IGU.

ClearVue's window technology has application for use in the building and construction and agricultural industries (among others). ClearVue has worked closely with leading experts from the Electron Science Research Institute, Edith Cowan University in Perth, Western Australia to develop the technology.
