PLACEMENT & SECTION 708A STATEMENT

The Directors of Gunson Resources Limited ("**Gunson**") are pleased to announce that a placement of 750,000 shares at 32 cents per share to a large European institution ("**Placement**") has been completed. This Placement raised a further \$240,000, bringing the total funds raised this month to \$1.2 million.

Use of funds

Funds raised under the Placement will be applied to further advance the Coburn Mineral Sand Project, fund drilling at the Mount Gunson Copper Project and for general working capital purposes.

Upon completion of this Placement today Gunson's share capital will have increased to 83.68 million shares.


