## Issue of Securities

Orbminco Limited (ASX: OBI) ('**Orbminco**' or 'the **Company**') is pleased to advise that it has today issued 234,375,000 ordinary shares to professional and sophisticated investors pursuant to tranche 2 of the share placement announced on 4 February 2026 and approved by shareholders at the general meeting on 10 April 2026 (**General Meeting**).

The Company advises that an additional \$250,000 in placement proceeds will be settled shortly with Shares relating to that amount to be issued and allotted thereafter.

The Company also advises that it has issued 32 million unlisted Options exercisable at \$0.04 each and expiring 3 years from issue (**Options**) to the Directors, Technical Committee members and Company Secretary as approved by shareholders at the General Meeting. The Company has further issued 21.6 million Options on the same terms to the Lead Manager of the Placement for capital raising services provided.

An Appendix 2A and Appendix 3G has been released in conjunction with this announcement.
