Update on Mongolian Operations

Orbminco Limited (ASX:OBI) (the **Company** or **OBI**) provides the following update on its operations at the Bronze Fox Project in Mongolia.

OBI has recently completed a large geophysical survey at Bronze Fox, including induced polarisation (IP) and gravity survey. Several IP anomalies have been identified to the west of the current resource and at Shuteen North. The results of the completed IP and Gravity surveys have reconfirmed the existing targets and identified additional targets for further review.

OB1 is also finalising an application for a mining lease over the Western portion of the current Resource¹. A successful mining lease application will allow the whole of the Resource to be considered for exploitation.

The Company also wishes to update the market on the pre-existing tax claim by the Mongolian Tax Authority (MTA) involving one of the Mongolian entities which holds certain tenements of the Bronze Fox Project as referred to in Kincora Copper Limited's (ASX: KCC) Quarterly Activities Report of today's date. A decision has been recently received by a lower court in favour of the MTA, and OB1 and Kincora Copper have taken immediate steps to lodge an appeal of that decision to the Supreme Court of Mongolia.

Based on advice received, the Company maintains that the claim by the MTA is without merit and at this time there is no clear indication of when this matter may be heard.
