Cleansing Notice – Strikeline Acquisition

Taruga Minerals Limited hereby notifies ASX under section 708A(5)(e) of the Corporations Act in relation to the issue of 40,000,000 shares the the vendors (or their nominee/s) of Strikeline Resources Pty Ltd in consideration for the acquisition of a 100% interest in Strikeline, as set out in the Appendix 2A dated 11 May 2021 (Consideration Shares).

In addition to the Consideration Shares, the Company has issued 3,900,000 shares to advisers of the Strikeline acquisition (**Adviser Shares**), without disclosure, under Part 6D.2 of the Corporations Act. The Company, as at the date of this notice, has complied with:

- (a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
- (b) section 674 of the Corporations Act.

As at the date of this notice, there is no information to be disclosed that is "excluded information" within the meaning of section 708A (7) and 708A (8) of the Corporations Act.

The Consideration Shares and the Adviser Shares were issued out of the Company's existing LR7.1 placement capacity.
