



## Notice Under Section 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Cth)

On 21 January 2026, Taruga Minerals Limited (**Company**) issued 102,287 fully paid ordinary shares (**Shares**) following the conversion of 102,287 unquoted options at an issue price of \$0.015 each.
