RESULTS OF ANNUAL GENERAL MEETING

At the Company's Annual General Meeting this morning, all resolutions were supported in accordance with the Director's recommendations. For the second year in succession, the first resolution was opposed by more than 25% of votes submitted, automatically triggering a Spill Motion, which was rejected by a 60% majority.

Commenting on the Annual General Meeting shareholder vote, the Managing Director David Harley said "It is pleasing that over half the Company's shares were voted, with a substantial majority of shareholders who voted being in favour of the Directors' recommendations".

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act, details of the resolutions and the proxies received in respect of each resolution are set out in the attached proxy summary.
