SCHEME UPDATE AND AMENDED TIMETABLE

Lithium Power International Limited (ASX: LPI) ("**LPI**" or the "**Company**") refers to the proposed scheme of arrangement pursuant to which a wholly-owned subsidiary of Corporación Nacional del Cobre de Chile ("**Codelco**"), Salar de Maricunga SpA, will acquire 100% of the share capital of LPI ("**Scheme**").

As previously announced on 18 October 2023 and as detailed in the Scheme Booklet dispatched to shareholders on 21 December 2023, the Scheme remains subject to the Treasurer (or his delegate) providing a written notice under the *Foreign Acquisitions and Takeovers Act 1975* (Cth) stating that, or to the effect that, the Commonwealth Government does not object to the Scheme, on terms acceptable to Codelco (acting reasonably) ("**Foreign Investment Review Board Approval**").

LPI advises that the Foreign Investment Review Board has requested an extension to the statutory deadline for the making of its decision to 9 February 2024. This is a standard extension request and the LPI Board is not currently aware of any reason Foreign Investment Review Board Approval will not be received (or any other matters that would result in the nonfulfillment of any conditions to implementation of the Scheme).

In light of this, LPI requested that the Federal Court of Australia ("**Court**") move the date of the Court hearing for the approval of the Scheme ("**Second Court Hearing**"). The Court today made orders moving the Second Court Hearing to 10:15am (AEDT) on Tuesday, 13 February 2024.
