

Notice Under Section 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)

On 3 September 2026, Taruga Minerals Limited (**Company**) issued 677,771 fully paid ordinary shares (**Shares**) following the conversion of 677,771 unquoted options at an issue price of \$0.015 each.
