The Directors of Gunson Resources Limited ("**Gunson**") are pleased to announce that a placement of 4,599,153 shares at 35 cents per share to raise \$1,609,704 ("**Placement**") has been completed.

**Use of funds**

As announced on 15<sup>th</sup> May 2006, funds raised under the Placement will be applied to further advance the Coburn Mineral Sand Project, including some long lead engineering items for the proposed mine development and for general working capital purposes.

Upon completion of this Placement on 17<sup>th</sup> May 2006 Gunson's share capital will have increased to 89.29 million shares.


