



Project Location Map







Mount Gunson JV





- Commenced 15th June 2006
- Noranda Pacific to spend \$3.5M in 3 years for 51% interest
- Then another \$6.5M in extra 3 years for additional 24%
- Total \$10M in 6 years for 75%
- Xstrata took over Falconbridge in August and now owns Noranda Pacific
- Gunson to manage exploration from late November onwards





Coburn – Regional Setting








Amy South Drilling Program 2006



Zircon Supply/Demand Forecast






Eneabba – % of World Zircon Production 1980-2004

Coburn Definitive Feasibility Study (DFS)



- 90% complete.
- Tender prices being negotiated downwards
 capital and operating items.
- Metallurgy for Ilmenite / tolling plants being finalised.
- DFS completion target early 2007, to coincide with final environmental approval.

Conclusions



- Permitting and financing to be completed H1 2007.
- 12 month construction period envisaged.
- Coburn is the third largest greenfield zircon development project in the world.
- Mount Gunson drilling early 2007.
