



## NATIONAL STORAGE REIT ASX ANNOUNCEMENT

### SCHEMES APPROVED BY COURT AND BECOME LEGALLY EFFECTIVE

National Storage REIT (ASX:NSR) (**NSR**) is pleased to announce that the Supreme Court of New South Wales (**Court**) has today made orders approving the share scheme of arrangement and provided the second judicial advice in respect of the trust scheme (together, the **Schemes**), under which entities established and jointly indirectly owned by a consortium of the Brookfield Funds (being funds owned or managed by Brookfield Asset Management Ltd or its affiliates and their managed funds) and affiliates of the GIC Investor will acquire all of the issued stapled securities of NSR (**NSR Securities**).

NSR confirms that an office copy of the Court orders (attached), and the executed Supplemental Deed amending the constitution of the National Storage Property Trust, have today been lodged with the Australian Securities and Investments Commission. The Schemes have accordingly become legally effective.

It is expected that trading in NSR Securities will be suspended from the close of trading today.

### TERMS OF JUDGMENT/ORDER

#### VERDICT, ORDER OR DIRECTION

Brereton J makes the following orders:

#### Definitions

In these orders, capitalised terms have the same meaning as those adopted in orders made on 10 March 2026.

The Court orders that:

1. Pursuant to ss 411(4)(b) of the Corporations Act, the Share Scheme proposed between National Storage Company and NSR Securityholders (as holders of National Storage Shares), the terms of which are set out in Annexure B of the Scheme Booklet, is approved.
2. Pursuant to s 411(12) of the Corporations Act, the First Plaintiff be exempt from compliance with the requirements of s 411(11) of the Corporations Act in respect of the Share Scheme.
3. The First Plaintiff lodge with ASIC a copy of the approved Share Scheme at the time of lodging a copy of these orders.
4. Pursuant to s 63 of the Trustee Act that, NSR Securityholders having voted in favour of the Trust Scheme Resolutions by the requisite majorities, the Second Plaintiff would be justified in:
  - a. giving effect to amendments of the National Storage Trust Constitution, as set out in the National Storage Supplemental Deed, to implement the Trust Scheme;

b. giving effect to the provisions of the National Storage Trust Constitution (as amended by order 4a above); and

c. doing all things and taking all steps necessary to give effect to a transaction whereby all National Storage Units stapled to National Storage Shares will be unstapled.

5. These orders be entered forthwith.
