## Issue of Tranche 1 Placement Shares

Orbminco Limited (ASX: OBI) (**'Orbminco'** or **'the Company'**) is pleased to announce that it has today issued 62,500,000 ordinary shares to professional and sophisticated investors pursuant to the share placement announced on 4 February 2026 (**'Placement'**).

The Company confirms that it has issued a total of 62,500,000 ordinary shares at \$0.016 per share to raise \$1m (**'Shares'**), with 43,394,259 shares issued pursuant to the Company's placement capacity under ASX Listing Rules 7.1 and 19,105,741 ordinary shares under ASX Listing Rule 7.1A.

As advised in the Company's ASX announcement on 4 February 2026, the Company will seek shareholder approval for Tranche 2 of the Placement at a General Meeting to be held mid to late March 2026.

An Appendix 2A has been released in conjunction with this announcement.
